#### **The Curriculum**

##### **Program actions:**

Democracy and Justice Studies - modify requirements for the major (largely to accommodate discontinued courses), approved by DJS Chair, LAS Dean, AAC, and Provost for Fall 2013.

Environmental Policy and Planning - add PEA 380 Global Environmental Politics and Policy to core requirements of major, approved by PEA Chair, LAS Dean, AAC, and Provost for Fall 2013.

History - revision of elective choices of upper level courses in major and minor (including courses in DJS and FNS), approved by History Chair, HUS Chair, LAS Dean, AAC, and Provost for Fall 2013.

Human Biology - change in requirements for major, minor, and area of emphasis, approved by HUB Chair, LAS Dean, AAC, and Provost for Fall 2013.

Information Science - revision of language requirement for major, approved by ICS Chair, LAS Dean, AAC, and Provost for Fall 2013.

Interdisciplinary Studies - revision of credit requirements in area of emphasis in Leadership in Public Service, approved by IST Chair, PEA Chair, LAS Dean, AAC, and Provost for Fall 2013.

Nursing - replacement of seven upper level courses with eight different upper level courses in the core requirements of the major, approved by Chair of Nursing, PS Dean, AAC, and Provost for Fall 2013.

Public Administration - add PEA 380 Global Environmental Politics and Policy to elective options for the major, approved by PEA Chair, LAS Dean, AAC, and Provost for Fall 2013.

Social Work - a proposal to dissolve the collaborative MSW in favor of separate MSW programs at the two collaborative universities has been approved by the Faculty Senate.
