The Curriculum

Program actions:

Accounting - replace BUA 215 Intro to Business Statistics and BUA 217 Advanced Business Statistics with BUA 216 Business Statistics as required supporting courses for the major, approved by BUA Chair, AAC, Dean, and Provost for Fall 2011.

Biology - add BIO 490 Biology Seminar for all areas of emphasis in the major, approved by chairs of Human Biology and Natural and Applied Sciences, Dean, and Provost for Fall 2011.

Business Administration - replace BUA 215 Intro to Business Statistics and BUA 217 Advanced Business Statistics with BUA 216 Business Statistics as required supporting courses for the major, minor, and area of emphasis for AA degree, approved by BUA Chair, AAC, Dean, and Provost for Fall 2011.

Environmental Policy and Planning - change of requirements for major and minor, approved by PEA Chair, AAC, Dean, and Provost for Fall 2011.

Humanistic Studies - change requirements for area of emphasis in Religious Studies by replacing HIST 410 History of Christianity with HIST 335 Perspectives on Human Values: the Medieval World in requirements, approved by HUS Chair, Dean, AAC, and Provost

Humanistic Studies - change of major and minor requirements for Western Culture area of emphasis by eliminating the crosslisting of FNS courses (so they are FNS courses, not HUS/FNS courses) and adding upper level FNS courses as possible electives for both Western Culture and Culture and Values areas of emphasis, approved by Chairs of FNS and HUS, AAC, Dean, and Provost for Fall 2011.

Interdisciplinary Studies - change of Organizational Communication area of emphasis in title (to Corporate Communication) and in requirements for the BA and BAS degrees, approved by Chairs of IST and Communication, AAC, Dean, and Provost for Fall 2011.

Interdisciplinary Studies - add area of emphasis in Leadership and Public Service for both BA and BAS degrees, approved by Chairs of IST and PEA, AAC, Dean, and Provost for Fall 2011.

Political Science - changes in requirements for the major (require both POL SCI 100 Global Politics and Society and POL SCI 101 American Government; delete three elective courses - PHILOS 326, SCD 362, and URS 351; and reducing the maximum number of credits for POL SCI 497 Internship to 3), approved by Chairs of Political Science, SCD, and URS, Dean, AAC, and Provost for Fall 2011.

Public Administration - change in requirements for area of emphasis in Public Management (add POL SCI 318 to list of courses in the analytic methods category and move ECON 305 and PEA 409 from analytic methods to public policy category), approved by PEA Chair, AAC, Dean, and Provost for Fall 2011.
