Heba asked if all the auxiliaries are staying flat. Kim said yes and Health and Counseling decreased. Kim said Student Life increased but they are including GTP. Reed asked if the segregated fee is \$635. Kim said we haven't set the segregated fee rate yet.

Kim entertained a motion to package the auxiliary budgets. Jeff motioned. Megan second. Trevor called the question. Roll call vote passed 9-0-0.

Kim entertained a motion to approve the auxiliary budgets for \$5,664,010. Jeff motioned. Katie seconded. Megan called the question. Roll call vote passed 9-0-0.

Kim said now we will talk about setting the segregated fee rate for next year. Heba asked John to explain the unused allocation (fallout). John said the orgs bring in revenue and they do not use all of the money allocated to them. We should not charge that amount in the segregated fee so we took it out. The only thing that will be affected is the reserve if that number is off. John said the number we are look for with the segregated fee is \$1,356 which is a 1% increase from last year. John asked if the board wants to build that reserve again by increasing the segregated fee by 1-2%. Shawn said this year we made a pitch to all the auxiliaries to have a flat budget. We are trying to build up the reserve again. Reed asked how much is in the reserve. Kim said right now the balance is \$156,000. We would like to see it around \$300,000. The reserve a few years ago became really high and that is when the road projects started. We also used to take that fallout out of the reserve. One way to save up for projects in the future is to build up the reserve. Kyle said we are trying to make it cheaper in the future by increasing the segregated fee now. Reed said if we want to increase the reserve by \$100,000 we need to increase the SUF rate by \$23. Heba asked if the money that used to go to the Union is going into the reserve. John said you have been losing money every year because expected revenue never came in. Kim said last year we took money out of the reserve to keep the segregated fee the same. This year we don't have to do that because the Union debt is not in the budget. John said we used to have a higher FTE but we never met it so we were losing money every year. John discussed past segregated fee rates. The board discussed the segregated fee rate for next year. Kim said that she proposes a 1-2% increase over the segregated fee this year. The board discussed the amount needed for the segregated fee in the next year.

Kim entertained a motion to table the segregated fee approval. Jeff motioned. Josh seconded. Jeff called the question. Majority of the board voted to table to approval.
