Approval of the Smoking Policy: Senator Tyrrell motions to approve the smoking policy. Senator Janke seconds the motion. Senator Tyrrell calls the question. Roll call vote: **MOTION PASSES 17-2-1.** 

Election Guidelines: Student Court Chief Justice Ryan Mach:

- 1) Please refer to the website for the election rules. Section 7 of the Election Mechanics:
  Representation....the winning ticket must retain 40 percent of the total votes cast. This pertains to the election of write-in tickets. In the event that two tickets reach the 40 percent threshold, a runoff election will be conducted. This is the biggest change made, and was approved by the Senate earlier this year.
- 2) Referendums: The Court must receive all referendum proposals fifteen days in advance of the election date.
- 3) See also: Section 5, Subsection 2, Subsection 7- Infractions. Particularly coercion of votes.

- 4) The candidate contract has also been removed. Write-in candidates must, in order to remain viable, adhere to all campaign election rules and regulations. The candidate contract is no longer necessary. "all write-in candidate must adhere to Sections 3, 4, and 5."
- 5) Election materials will be made available March 9, 2009.
- 6) Materials are due March 26, 2009.
- 7) Material review and confirmation (the court will review all materials submitted to ensure viability and compliance of the elections guidelines (rules and regulations)) by the court: March 27, 2009
- 8) Referendum proposals due March 30, 2009
- 9) Election debate is April 9, 2009
- 10) Election Day is April 14, 15<sup>th</sup>, 2009
- 11) Note: *BSU v. SUFAC* opinion is still in the process of being written. The opinion should be completed by Friday.
