- g. System Rep. (Liaison: Hrivnak)
 - i. Meeting took place on February 10 in Madison.
 - ii. Campuses expressed a need for a ban on concealed carry.
 - iii. UWGB students defeated a resolution to ban concealed carry at UWGB.
 - iv. No changes being made to policies concerning shared governance.
 - v. No changes being made to policies concerning Title IX.
 - vi. University Holiday Calendar: Campuses set their own hours. There is a State Statute (WI 99.5) that defines legal holidays for State employees.
 - vii. Senate Bill 30 (Budget Bill) Discussed 2+2 pay plan Madison talking about fixed-dollar pay increase rather than a percentage increase. Should UWGB begin to discuss such a proposal? Katrina will invite the Provost to attend an upcoming ASC meeting to discuss this.
 - viii. UWS is about \$400m better off right now that the last budget.
 - ix. Tuition cut of 5% (approximately \$35m) may not be a part of the final budget.
 - x. Self-Insurance Plan might not be approved. Rep. Nygren, (Joint Chair of Finance Comm.) does not approve of the proposal.
 - xi. Faculty workload: Small percentage of funding will be tied to performance-based criteria. Katrina will ask the Chancellor to discuss this with the Committee.
 - xii. Discussion about UWS students being required to complete an internship.
 - xiii. Transferability to be made easier.
 - xiv. Discussion on Segregated Fees.
 - xv. Academic Freedom summary money to be set aside to define what "Academic Freedom" is, and then to codify it.
 - xvi. Discussion on a three-year degree option.
 - xvii. UWGB lost tribal funding in the last budget. What about this year?
 - xviii. Timeline for budget: Legislature is set to vote on the budget in July.
 - xix. Discussion about not wanting the Governor deciding what constitutes "performance metrics."
