#### **The Curriculum**

##### **Program actions:**

Art - change requirements for the minor by combining the 2-D and 3-D areas of emphasis into a single Studio Arts emphasis, approved by Chairs of Art, AVD, LAS Dean, AAC, and Provost for Fall 2012.

Global Studies - change requirements for minor by adding POL SCI 380 Global Environmental Politics and Policy as an elective, approved by Chairs of Political Science, Global Studies, PEA, LAS Dean, AAC, and Provost for Fall 2012.

Health Information Management and Technology - a new on-line degree program, approved by Chairs of Nursing and ICS, AAC, LAS and PS Deans, Faculty Senate, Provost, and Board of Regents for Fall 2012.

Music - change requirements for BM Performance Option and BA in Music by splitting the vocal and instrumental options for the BM into two separate options and adding MUSIC 301 Basic Recording and MIDI Techniques to requirements for the BA, approved by Chairs of Music, AVD, LAS Dean, AAC, and Provost for Fall 2012.

### **Personnel Practices**

A new UW-Green Bay Policy on Post-Retirement Employment has been approved by the Academic Staff, the Faculty Senate, and the Chancellor, Dec. 8, 2011.

The Faculty Senate approved a change in the periodicity of merit reviews for tenured faculty. Units have options but tenured faculty must be reviewed at least once every five years.

### **Governance Structures and Policies**

The Academic Staff amended its bylaws on the officers of the Academic Staff Committee, approved by the Academic Staff Assembly, Nov. 17, 2011.

As part of the approval process for the on-line collaborative degree in Health Information Management and Technology, a governance structure in the form of an executive committee was created for the program, approved by LAS and PS Deans, the Personnel Council and Academic Affairs Council acting jointly, the Faculty Senate, the Provost, and the Board of Regents.

The Faculty Senate at its January 2012 meeting approved the creation of two new budgetary units carved out of Arts and Visual Design. One is Theatre/Dance and the other is Music.

The Code regarding graduate programs has been changed to reflect changes in the administrative structure and titles.
