

## Nursing | 2016-2017 Assessment Plan

1. Please review last year's assessment results (2015-2016) as well as the Academic Program Assessment Report with the faculty in your program. How does your program plan to take these results into consideration in future programmatic planning?

## For 2016-2017, recommendations for continued work on this outcome:

Due to the importance of this content/program outcome, the BSN Program Assessment Committee will continue to monitor data related to program outcome #5 including healthcare finance and health policy.

The following steps have been taken to date:

- 1. Held a Brown Bag session with faculty to share assessment results and discuss content coverage of finance in the BSN program (Addendum 1) in fall 2016.
- 2. Because of continual changes to healthcare finance (e.g., Affordable Care Act), there is a need to continue to provide updated and current content in this area. Specific improvements to curriculum recommended include:
  - NUR 407: Theoretical Foundations of Nursing
    - Expand course readings to include a chapter on Healthcare Economics (Black, 2017).
    - Replace midterm quiz with a lesson regarding healthcare finance & its relationship to nursing theory.
    - Revise existing exam questions on healthcare finance to those that test economic theory and relationship to nursing theory.
  - NURS 490: Synthesis for Nursing Practice
    - Revise course lessons to enhance student understanding of healthcare finance/economics and health policy, particularly related to major health policies including Medicaid, Medicare, and the Affordable Care Act.
    - Enhance content on healthcare reimbursement/finance models (e.g., value based purchasing, capitated payment, bundled reimbursement).
