

Bird Banding Volunteer Assistant—Hawk Banding

Position Description:

Under the direct supervision of the Master Bander, Banding Volunteers will assist with: searching for hawks and hawk nests in the woods of northeast Wisconsin, setting up nets or live traps, monitoring nets or traps or nests for hawks, removing hawks from nets or traps, carrying equipment into the woods, weighing, measuring, and determining age and gender of hawks, banding adult or young hawks, and recording data.

Volunteers need to determine the schedule that works for them along with the days that hawk banding can be done. Hawk banding is done in the spring/summer (March, April, May, and June) and in the fall (September, October, and November) though is very weather dependent.

Banding Volunteers will not assist with other events, activities, or projects at Barkhausen Waterfowl Preserve, nor will they be under the supervision of other Barkhausen staff. Experience will be limited to hawk banding operations only.

Volunteers need to sign a Brown County Volunteer Form, have health insurance, and have had a tetanus vaccination within the past 10 years. Occupational hazards include: hands pierced by sharp talons, deer and wood tick bites, mosquito bites, and any and all infections and diseases that are associated with these hazards.

This is an unpaid position. UW-Green Bay students are encouraged to apply for the Great Lakes Higher Education Internship Grant or other grants for funding.

Personal Equipment Needed:

Rubber boots, field clothing, binoculars, and cell phone. Hawk banding volunteers need the mental, emotional, and physical toughness as well as stamina to work with wild animals outside, and stay with a project through tough conditions. They must also be able to go without food or using a cell phone for 4 hours and must strictly focus on the banding project.
