Tailgate party includes burgers, brats, wings, soda, water and sides to feed the winner and 35 friends. In order to be entered in the drawing, individuals must post publicly about Phoenix Pride to Facebook, Twitter or Instagram using #uwgbphoenixfriday on Friday, February 28, 2020. One entry per platform, per person. Entry in the Sweepstakes does not constitute entry into any other Sweepstakes, contest or promotion. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the University of Wisconsin-Green Bay (the "Sponsor"), whose decisions shall be final and legally binding in all respects.
