

Krash the Kress – Associated Bank Tuition Give Away Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE A CURRENT STUDENT OF UW-GREEN BAY OR UW-GREEN BAY CAMPUSES AT MARINETTE, MANITOWOC AND SHEBOYGAN OR A FALL 2018 GRADUATE OF UW-GREEN BAY.

1. **SWEEPSTAKES DESCRIPTION:** As part of UW-Green Bay's Homecoming and Krash the Kress 2019, 1,300 seats are reserved for current students of the University of Wisconsin Green Bay and the UW-Green Bay campuses of Marinette, Manitowoc and Sheboygan AND 100 seats are reserved for admitted students of UW-Green Bay. As part of the evening's activities, there will be a student drawing for a semester of in-state UW-Green Bay tuition valued at \$3,939 toward the end of the Green Bay men's basketball game vs. UW-Milwaukee (game begins at 7 p.m. on Friday, February 1, 2019 and will be played at the Kress Events Center). If the winner is a current or admitted student, the UW-Green Bay Alumni Association will issue a check to UW-Green Bay for \$3,939 and the funds will be added to the student's SIS account. If the winner is a UW-Green Bay Fall 2018 graduate, a check for \$3,939 will be issued to the winner.
2. In order to be entered in the drawing, individuals must be a current or Fall 2019 admitted student of UW-Green Bay or UW-Green Bay campuses at Marinette, Manitowoc or Sheboygan or a Fall 2018 graduate of UW-Green Bay. Additionally, individuals must register to attend Krash the Kress on Friday, February 1, 2019, must write their name on a drawing slip and place it in the drawing container and must be in attendance at the time of the drawing. One (1) entry into the Sweepstakes per person. Entry in the Sweepstakes does not constitute entry into any other Sweepstakes, contest or promotion. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the University of Wisconsin-Green Bay Alumni Relations Office whose decisions shall be final and legally binding in all respects.
3. **SPONSOR:** "Associated Bank Tuition Giveaway" (the "Sweepstakes") is sponsored by Associated Bank, 433 Main Street, Green Bay, WI 54301, United States.
4. **ELIGIBILITY**
Open to current students and Fall 2019 admitted students of UW-Green Bay or UW-Green Bay campuses at Marinette, Manitowoc or Sheboygan or Fall 2018 graduates of UW-Green Bay. Offer void where prohibited by law, or otherwise restricted. All federal, state and local laws and regulations apply. All eligibility is subject to all federal, state, and local laws and regulations. All entries submitted are the property of the Sponsor.
5. **HOW TO ENTER:**
By January 25, 2018 or when 1,400 students have registered for Krash the Kress.
 - **Method of Entry:** You must register for Krash the Kress held on Friday, February 1, 2019 at the Kress Events Center at <https://www.eventbrite.com/e/krash-the-kress-2019-students-registration-49955109076> by Friday, January 25, 2019 or before the 1,400 student seats are taken through prior registrations. Registration is on a first come, first served basis with 1,300 seats available for current students and 100 seats available for admitted students.
 - You must write your name on a drawing slip at Krash the Kress registration and drop it into the drawing container.
 - You must be present at the time of the drawing.
 - Entries made by any other individual or any entity, including, but not limited to, commercial sweepstakes subscription notification and/or entering services, will be declared invalid and disqualified for this Sweepstakes. Tampering with the entry process or the operation of the Sweepstakes is prohibited and any entries deemed by the Sponsor,

in its sole discretion, to have been submitted in this manner will be void. **Any attempt to use multiple names or other tactics to enter more than the stated limit to inflate the number of entries in the Sweepstakes by any entry will result in the disqualification of the associated entry from the Sweepstakes and all associated registrations will become void.** Entries generated by a script, macro, or other automated means will be disqualified. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. “Authorized account holder” is defined as the person who is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address.

6. **PRIZES/ODDS:** Participants have a one in 1,400 chance of winning.
7. **Prize:** The Prize will be awarded only if the potential Prize Winner fully complies with these Official Rules. Prizes are non-assignable and non-transferable.
 - If the winner is a current or Fall 2019 admitted student, the UW-Green Bay Alumni Association will issue a check to UW-Green Bay for \$3,939 and the funds will be added to the student’s UW-Green Bay SIS account. Current / continuing students will need to be enrolled for Spring 2019.
 - If a branch campus student wins, the UW-Green Bay Alumni Association will issue a check to UWC to distribute to the student.
 - Admitted students will need to be enrolled for Fall 2019. Awards will be forfeited if a student cancels enrolment or withdraws during the 100% refund period (generally the first two weeks of class).
 - If the winner is a December 2018 graduate, a check for \$3,939 will be issued directly to the winner.
 - For all students other than the December 2018 graduates, the award will be forfeited if the student withdraws during the 100% refund period.
8. **WINNER SELECTION AND NOTIFICATION:** There will be a total one (1) drawing to award one (1) prize total. A random draw will be conducted on the following schedule:
9. Sweepstakes drawing will be conducted from the one drawing container at Krash the Kress registration. Conduct of the Sweepstakes and the drawing are under the supervision of the Administrator. Potential prizewinners will be notified in person and/or by phone and/or by email or mail or express mail, whichever is deemed appropriate by the Administrator, using the contact information provided at the time of entry. Sponsor shall have no liability for any potential prizewinner notification that is lost, intercepted or not received by any potential prizewinner for any reason. If, despite reasonable efforts, any potential prizewinner does not respond within three (3) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential prizewinner, such potential prizewinner will forfeit his or her prize and an alternate winner may be selected. If any potential prizewinner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential prizewinner will be disqualified and an alternate prizewinner may be selected from all remaining eligible entries.
10. **GENERAL PRIZE RESTRICTIONS/CONDITIONS:** By entering, each entrant agrees for entrant and for entrant’s heirs, executors, and administrators: (A) to release and hold harmless Sweepstakes Entities, the Board of Regents of the University of Wisconsin System on behalf of UW-Green Bay, and their respective officers, directors, and employees (collectively, “Released Parties”) from any liability, illness, injury, death, loss, litigation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from such entrant’s participation in the Sweepstakes and/or his/her acceptance, possession, use, or misuse of Prize or any portion thereof (including any travel related thereto); (B) that Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize’s quality or fitness for a particular purpose; and (C) to be bound by these Official Rules and to waive any right to claim any ambiguity or error therein or in the Sweepstakes itself, and to be bound by all

decisions of the Sponsor and/or Administrator, which are binding and final. Failure to comply with these conditions may result in disqualification from the Sweepstakes at Sponsor's sole discretion.

Administrator and Sponsor are not responsible for any typographical or other printing errors in the offer or administration of the Sweepstakes, including, but not limited to, errors in the printing of posting of the offer or in these Official Rules, the selection or announcement of the winner, or the distribution of any prize.

Any and all warranties and/or guarantees on any prize (if any) are subject to the manufacturer's terms thereof, and winners agree to look solely to such manufacturer for any warranty and/or guarantee. Any portion of an awarded prize that remains unclaimed or expires will become void.

12. **DISQUALIFICATION/FORCE MAJEURE:** Sponsor is not responsible for lost, late, mutilated, misdirected, illegible, incomplete, inaccurate, or stolen submissions or prize notifications. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsman-like or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. In the event an insufficient number of eligible entries are received and/or Sponsor is prevented from awarding prizes or continuing with the Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), then Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes.
