**Report by the Retiree Association President**

\*\* "Krash the Kress," the second annual mid-winter basketball outing, was held Saturday night, February 1, 2019. Retirees and guests got a tailgate meal, beverages, music, a Phoenix t-shirt, tickets to the big game, and a chance to support the home team along with alumni, community and current students for a low price of \$20.

\*\* A \$5 ticket discount to attend the professional production of the Broadway play "Lombardi" during any March 5-10, 2019 performance. This production was produced by the Weidner Center to help the community celebrate the 100th anniversary of the Green Bay Packers franchise.

In other news, Dan indicated retirees will no longer be getting the 10% discount at the Phoenix Bookstore due to new management by Follett. Retirees were invited to sign up to be notified for periodic discounts and will receive emails on discounts that can be used in-store or on line for dates listed.

**Financial Report**

Frank Madzarevic, Treasurer, gave the Board of Director's financial report. Profits this year were \$772 from the golf outing and \$1364 from our annual dinner, thanks to additional donations received. Our balances to date are: Endowed Scholarship \$38,763; S&E \$5,616; and Oral History \$778. The 2021-22 scholarship award will be \$1400 next year.

Jane Rank, chair of the Oral History Project, gave a brief update on the progress of the Project, which continues to do interviews, making them searchable and internet accessible.

## Approval of Bylaw Revisions with Respect to Size of Retiree Board and Appointment/Elections

President Spielmann introduced the resolution as recommended by unanimous vote of the current Board of Directors, and he explained the rationale by pointing to increased flexibility and effectiveness. A vote of those present at the annual meeting is required to finalize the bylaws change. Kathy Pletcher moved, and Jan Pum seconded, that the Retiree Association adopt the following language:

### Section 1. Board Members and Duties

**A.** The Board of Directors shall consist of ~~nine~~ **between seven and eleven** members of the Retiree Association. The members shall have two-year terms with vacancies ~~appointed~~ **elected** at the Annual Meeting. **In the event vacancies occur prior to the annual meeting, the Board may, by majority vote, fill such vacancies for the unexpired term.** All UW-Green Bay retirees are eligible for appointment to the Board. Successive terms are permissible. The Director of the Office of University Advancement or his/her designee shall be a non-voting adviser to the Board.

**B.** The Board members will annually elect a President, Vice President, Secretary, and Treasurer from among their members. **The Board members will elect a replacement, as needed, in the event a vacancy occurs in one of these positions.** Board members shall perform the duties prescribed by these bylaws.

**C.** Duties of the Board Members: The President shall be the chief officer of the Retiree Association, fulfilling all normal duties of that office including, but not limited to, presiding at all meetings of the Board of Directors, affixing an official signature to the Association documents, appointing the chairs or co-chairs of the committees, and representing the Association in an official capacity. ~~Vacancies on the Board of Directors shall be filled by appointment by the President in consultation with the Board.~~

The proposal passed with all "ayes."

### Election of New Board Members

Four current Board members continue for one more year: Pat Przybelski, Judi Pietsch, Chris Sampson and Dan Spielmann. Four of the five members of the Board who otherwise would have completed their terms agreed to accept nominations for re-election: Carol Emmons, Curt Heuer, Frank Madzarevic and Kathy Pletcher. Other nominations to the Board were Ken Fleurant and Barb McClure Lukens. With no other nominations from the floor, it was moved and seconded to approve the 10 members to the Board of Directors. The slate was approved unanimously
