- III. Housing Board has tabled the project until their June meeting
 - a. They offered these concerns
 - 1. If we're going with a roof mount, vs. ground mount, what is the advantage
 of using Small hall (which has 60 beds), vs. one of the other halls (e.g.
 Downham hall which has 194 beds)?
 - 2. What is the weight of the structure that would be mounted on a roof? Will the roof hold without new support?
 - 3. How will this structure impact the present wiring system and power panel?
 Will there be a continuing need to keep and maintain the present wiring for emergency systems?
 - 4. 20 year warranty and then what? How will repairs and replacement be funded after this point in time?
 - 5. We also still need to investigate liability insurance availability, cost, and who will pay for it if it is needed?
- IV. The Env. Affairs Committee is planning to attend the housing board meeting in June to discuss this project in front of the board in the hopes of paving the way for future years
