VIII. Discussion Items

- a. ***AMF request*** - AMF is a relatively new organization on campus and our two previous presidents haven't submitted budgets in the past. We heard about the Congo run a few weeks ago and we thought we would really like to do this in our organization. It was opened to all of our members and outside students who would want to take part in this. They usually don't join us for our support groups. We currently have 8 students registered and another student recently joined. So we have 9 students and the total cost is \$135 per person for registration. The money will be donated to Women for Women International. Amanda stated that they did toss around the idea of paying for t-shirts with the registration fee; however, they thought that it would be more important to give the money to the Women for Women International group in Congo. In the past we have participated in Relay for Life and we had 12 students take part in that. Julia clarified that 100% of the funds go to Women for Women International. This goes to supporting the women and her family in the Congo; she also receives certain classes.

Matt asked if we have an issue with funding this because of the donation. Yes. Jessica asked how we funded the Relay for Life in the past? Sophie stated that in the past we did pay for registration; however, it paid for t-shirts and other things for the students walking. We will talk about this next week and look at our past precedent and our guidelines.
