b. Chancellor Miller

- The mission of the school is important, just like the interaction with the community. Changes will be made over the next year to adjust to the budget.
- Discussed the importance of interdisciplinarity and how we must take a contemporary edge to continue to provide a quality education.
- The proposed budget has two changes: 1. Reduce base funding for the UW System. 2. Move from being a state agency to a state authority.
- Reduction in funding for higher education is not new and it is not a partisan issue.
- There is talk about making the cut smaller, but we are preparing for the worst. Discussions about what will be cut.
- Now March 4th: Preparing to talk to Board of Regents about the effects on UWGB.
- March 4th April 9th: Making preliminary decisions about considerations for cuts.
- April 9th July 1st: Complete and implement decisions so on July 1st we can operate on 4.68 million dollars less from the state.
- These reductions will not increase segregated fees, but a discussion will be had about how those fees are being spent.
- Student Employment will not stop. There is no hiring of faculty and staff members. Staffing levels will be reduced.
- There are concerns of Shared Governance. It is mandated in statutes, but many favor it and tenure. This won't go away even if we move to an authority. This would provide many economic benefits.
- Use your voice with legislators and tell them what you think. Organized responses are critical and helpful. Follow the resolution and try to make an impact.

- c. Mark Olkowski: Title 9 and Chapter 17 Presentation
 - UWS 17 is a state administration code that deals with student rules.
 - Currently, there is a limited scope. A change would mean better compliance with federal law, more rights for the victim/survivor/complainant, additional rights for accused respondent, attempt to make a difficult situation more fair and respectful for both sides.
