Explanation of the Court's decision to dock 5% of total votes from the Stepp-Lones ticket

• Through the Court's investigation (including interviews), we concluded that certain individuals were given permission to campaign on the ticket's behalf, and therefore the ticket was responsible for informing the individuals of the election rules and was also responsible for the campaigning actions of those individuals.

- The Court subsequently found that individuals campaigning on behalf of the ticket were found to be in violation of section V, B, 8 of the election rules by attempting to coerce votes.
- As a result, per Section V, A, 1 of the election rules, the Court has found that the ticket has demonstrated "willful disregard" of the election rules. The Court has therefore decided to dock the Stepp-Lones ticket 5% of their total votes.
