The morning will consist of a meeting of county human service administrators around the state of Wisconsin, to address BHTP related business. Agenda will be forthcoming. Lunch will be provided from approximately 11:00am – 12:00pm, with the afternoon training starting promptly at 12:00pm.

The afternoon we will be providing the training "*Supervising Employees at Risk of Moral Injury.*" Syracuse University is doing groundbreaking research in their "Moral Injury Project" for veterans who have been deployed. Their working definition of moral injury is: "Moral injury is the damage done to one's conscience or moral compass when that person perpetrates, witnesses, or fails to prevent acts that transgress one's own moral beliefs, values, or ethical codes of conduct."

In this seminar, we will discuss the implications of moral injury for human service professionals. In this work, you and your staff respond to incidents so painful or difficult that they break your heart, and violate your moral compass. You carry experiences that haunt you long after they have passed. Often, in your role as a supervisor, you need to support your staff emotionally through egregious events while also ensuring that your organization upholds it reputation of serving the community within the parameters of multiple administrative guidelines and statutory limitations. We will look at general examples of what moral injury "looks like" in human services and explore the risk factors leading to the crippling shame that can result. We will also discuss some of the emerging therapeutic tools, like adaptive disclosure, that are now being used to assist in the healing of deep moral wounds, to equip you to better support your staff.
