

## University Recreation (UREC) Summer Camps / Programs at the Kress Facilities

### 2021 Expectations / Recommendations

#### **UREC Summer Camp / 3<sup>rd</sup> Party Rental Expectations:**

- All coaches and contracted lessees associated with camp activities agree to:
  - Follow the current draft of the Department of University Recreation and Green Bay Athletics [Camps and Clinics Policy Manual](#) as applicable.
  - Abide by all current University, county and state COVID-19 protocols that are in place at the time of the scheduled camp activities including the face covering policy.
  - Agree to implement/incorporate the American Camp Association (ACA) Field Guide for Camps Version 1.3 ([Field Guide for Camps](#)) in their 2021 summer camp protocols and recommendations.
  - There will not be a camp store for selling food, beverages or merchandise.
  - Camp activities should be conducted in cohorts with a group size depending on the location. Max capacity of the DB and Kress is 40. Max capacity of the outdoor soccer fields is 25 per half of field. Cohort limit is 25.
    - Campers mix between groups but remain at least 6 feet apart and do not share objects (i.e. balls or other equipment)
    - Camps are allowed 15 minutes of contact that is closer than social distance recommendations (6 feet). After the 15 minutes of close contact, camps are expected to take a brief break.
    - Cohort uses a defined space (i.e. Kress Center, Bennett Gym, soccer field, etc.) as one singular group.
  - UREC and the University reserves the right to cancel or suspend any camp or 3<sup>rd</sup> party rental for non-compliance of COVID-19 guidelines and policies.
  - Transportation to and from Camp:
    - Drop Off / Pick Up
      - Send communications to parents/guardians that assign each camper their drop off or pick up time window. Explain the purpose of the window and encourage them to:
        - Minimize the time they take saying goodbye to allow for the continual flow of traffic
        - Say goodbye close to or inside their vehicles
        - Maintain physical distance with other parents/guardians and campers.

          - Baird parking lot (southwest corner of the Kress Events Center)
        - Outdoor camps
          - Leon Bond Road (road by loading dock)
      - Pick up Locations
        - Indoor camps
          - Baird parking lot (southwest corner of the Kress Events Center)

- Outdoor camps
  - Leon Bond Road (Road by Kress Events Center Loading Dock)

#### ***Additional Kress Events Center (KEC) Indoor Summer Camp Programs & Third-Party Rental Protocols & Considerations:***

- Facilities / Common Spaces: Activities are to remain in assigned gym space other than for the purpose of entering or exiting the KEC facilities or using the restrooms. Participants and staff should not:
  - Loiter in the hallways
  - Campers must keep their personal items in the space that they are assigned
  - Travel or rotate to or from other gym spaces during the course of the day's activities.
- Pool:
  - Swim camp or lesson program will need to have a certified lifeguard on the pool deck at all times.
  - For swim camp or lesson program, maintain 8-foot lane width in the pool and maintain spacing between swimmers (pool capacity set at 10 swimmers - one per lane in the lap pool (8) and two in the duck pond.
  - Locker Room / Changing - Swim camp participants will come dressed for swim.
  - Locker Rooms will not be available other than for use of the restroom.
    - Swim camp / lesson participant will leave the facility immediately upon the conclusion of the camp or lesson time.
  - All camp or lesson participants are required to provide their own pool equipment (i.e. kick boards, foam tubes, etc.).
- Testing:
  - If multiple campers arrive in a vehicle and one or more campers are waiting for a COVID-19 test result, all campers must wait in the vehicle until the last negative test result comes back.
    - If one of the campers tests positive in the vehicle, none of the campers will be allowed to participate.

#### ***Additional Kress Family Outdoor Recreation Complex Summer Camp Programs and Third-Party Rentals Protocols & Considerations:***

- Restrooms: Outdoor camps will be charged an additional cleaning and sanitization fee as assessed by Custodial Operations through Facilities Planning and Management to clean the outdoor restrooms.
- Food:
  - Outdoor camp participants could bring their own lunches or
  - Camp facilitator or lessee can coordinate with University Dining for available meal options.
