#### 3. CHANCELLOR'S REPORT

Greetings by Chancellor. Governor Evers about to arrive, so he warned us he'll have to duck out.

Three big updates.

- 1) Cofrin Building...Cofrin Tech and Ed Center needs about \$10 m to keep that project on schedule (mainly due to inflation and perhaps underestimation of costs). Seems likely to pass. Will show University plans after this happens. Architects planning to be here in Feb. Chancellor just visited new dorm...will be a FANTASTIC new place, much nicer than any dorms Chancellor lived in back in the day.
- 2) Library in Marinette, issue with "books in the dumpster". Wants to clarify so there's no misunderstanding. We publicly announced we would transform that space. Currently 88% of our library collection is digital. Of the remaining 12%, checkout rate is ~1.5%/year. Students ARE using the library, but they are using digital materials. Library followed all state processes to get rid of the books...offered them to UW System libraries, other libraries, Marinette, then a booksale. The remaining books get recycled....this happens every day of course. Chancellor not upset about media coverage (not really a story), but the reaction of our faculty and staff. We have a professional library staff that is owed our respect, they are amazing. Our librarians did not "choose" to throw away books, we need to give our Library Staff due credit, support, and respect.
- 3) Marinette. Ch. Wants to thank all the faculty and staff at Marinette for their support over the last weeks. We had no choice on Friday but to go public about the negotiations with Marinette, because of the notes and documents that were leaked. Another statistic: Students in the Marinette area attending UW-Green Bay since the merger....UP by 250 students. We essentially tried the same things at all three additional campuses, and some things worked really well in Sheboygan and/or Manitowoc...those things didn't work that well in Marinette. We need to get in front of a decision that we don't really want to make. We have to be good stewards of the state's resources. Excited about the plans for the theater there. We still want to education as many people as possible in the region, even if the campus there is not functioning in the same way as before.

Chancellor appreciates all we're doing and happy to take questions.

Q (Karau): Where are these 250 students? Green Bay? Online? Ch: We don't know....some are in high school, for example. But our presence is increasing.

Q (Kallgren): Thanks for addressing the library situation. Paula et al. handled the situation as best as possible. Regrets that the situation wasn't communicated in a more timely fashion. For example, we didn't know that the books were offered to the community, etc. That information, had it been shared, would've changed the situation significantly. More communication within the university community

is often the key to avoiding controversies. Dr. Kallgren asks Chancellor to trust the community in the future. Ch: Fair comments for sure. We do our best, its not always perfect. We did announce the sale, but apparently we didn't communicate as well as we should. Ch. Wants us to ask questions internally first before going external. But, fair comments.

Chancellor wishes us a nice semester, noting the energy on campuses is terrific. Have a great rest of the meeting.

#### 4. OLD BUSINESS

# a. Core Curriculum Proposal (Valerie Murrenus Pilmaier, Bree Lybbert)—Second Reading/Vote

Intro: Terry notes that we need a motion to approve, etc.

Valerie...Bill has his hand up? Terry...proceed. Val MP thanks everyone for the time you've invested in this project, we've been working on this for two years. Five parts to this revised document. Bree?

Bree...welcomes comments, and recognizes that its in the Senator's hands.

## Bill Sallak: Move to postpone until Feb. Senate meeting (Sallak/Campbell)

Sallak: A number of energetic discussions about the Gen. Ed. discussion....Music has three suggestions, and other units have some, too. Two hours isn't enough time to get through it mindfully. Concerned about appeals/requests for exceptions process. Too vague of a process, perhaps? Example, there are 193 300 and 400 level courses, and the current policy is to exclude those without an exception.

If the motion passes, Sallak proposes open forum (according to our Senate Rules)

Mark Karau: Understands concerns, but we've had 1.5 years of gathering feedback, and repeated changes. Is another month going to make the difference? At some point we're going to have to make a decision. So, reluctant to vote in favor of postponing.

Michelle McQuaid Dewhirst (Music)....has grave concerns about Music's curriculum under the proposal. We've given feedback, but not enough changes to allay her concerns. Afraid of an "amendment pallooza" which may happen.

Sallak: Acknowledges Karau's concern about "glacial" pace of process, and acknowledges the hard work of the Committees in this massive task. Subject matter expertise from Music about the unfeasibility of the language hasn't been heeded. Almost impossible to imagine how courses in music can meet all the objectives. We need another month to get things squared away. Thank you.

Alison Gates. I'm confused, we (working group) did listen to Music experts and took them into consideration. Not sure what the objections are. Asked Music to provide guidance/new language, and didn't get it? In our recommendations document, we did suggest a re-structuring of the Gen. Ed. Council. One of the goals of Gen. Ed. reform is to reduce 300/400 level courses with lots of prereeqs, and hopefully many of those courses will NOT get an exception. But, the programs still have the power to put forward the courses they want.

Sallak: Respects what Alison said, but states that Michael Rector doesn't feel his feedback was incorporated into the proposal.

Terry: Any other discussion?

Vote on motion to postpone: 17 yes/22 no/1 abstain. Motion Fails.

Motion to accept core curriculum proposal (Dirienzo/Karau).

Sallak: Move to amend the proposal: NO SECOND

(Move to strike the third bullet point: "course must be 100 or 200 level course"): This was not considered due to a lack of a second to the motion.

Berns-Herrboldt: Wishes to amend the second objective of Env Sustainability [Berns-Herrboldt/Wefferling]

EnvST 2: Students will articulate an understanding of the scientific principles of environmental sustainability (that may include Traditional Ecological Knowledge) and their interrelation with the natural world through multiple disciplines, systems and diverse sources of information and inquiry.

Berns-Herrboldt notes that NAS and First Nations faculty met to hammer out this revised objective.

McQuaid-Dewhirst: We in Music are afraid that basically none of our courses will fit the current objectives. [Terry....this is out of order]

Sallmann supports the amended language.

Voelker helped craft and supports this amended language. How we understand Sustainability is important, and on the Sustainability Committee they feel its important for sustainability to be taught across the curriculum.

Abler: Comment, this amendment doesn't limit to science courses, right? Berns-Herrboldt...our intent was to allow the committee to decide, but that science is indeed fundamental to sustainability.

Malone: We considered that other empirical methods (besides quantitative science) could qualify, for example historical analysis and observations.

## VOTE on the Amendment to the Sustainabilty Criterion: 33 YES/1 NO/3 abstain. Motion Passes.

R. Islam: Thanks the committee. Feels there's an overlap with Human Cultures and Global Perspectives

Islam/Choudhury moves to change the learning outcomes, combining those for Human Culture and Global Perspectives, as follows:

#### **Human Cultures & Global Perspectives**

*HC&GP* 1: Students will identify and evaluate human values and ethical perspectives in their contemporary and historical contexts.

*HC&GP* 2: Students will examine a range of historical, literary, philosophical, and other cultural texts produced in a variety of cultures.

*HC&GP 3*: Students will analyze the ethical, social and environmental consequences of human actions and decisions on the natural and human world and global systems.

Vandenhouten: Are we just consolidating the categories, or also reducing the number of credits? Islam: Wants to reduce the credits to three.

Brusich: Credits Jared Dahlberg (HUB) for the language. Provides rationale for this, pointing out similarities of the two sets of objectives, and combining them.

Choudhury: Supports the motion. Too much overlap between the two old categories. Subjects not reduced, only total gen ed credits.

Heidi Sherman: I worry about this. [Terry corrects her on the categories being discussed]. Sherman understands about saving three credits, but this is being proposed with no preparation....I'm really worried about it, wants more time to process. It negates work by several units.

Sallmann: We just had a meeting to discuss this, Social Work wants MORE gen ed, not less. Notes that these categories are different, one is internal to our culture, the other is external. Worried about ignoring one or the other. Opposed to this.

Voelker: (guest) Opposes this amendment, these are distinct categories. We live in a very complex world in terms of cultures and ethnic diversity. Students should get both types of learning, and wants 6 credits retained.

Phoenix: Also against combining these categories. Students wouldn't get total exposure to both categories at this point.

Choudhury: We are not getting rid of either category, but no one has explained the overlaps.

Brusich: This subject has been brought up to committee on numerous occasions, and since it wasn't heeded, this is going through Senate, we weren't trying to go around the committee. We've been quite thoughtful in trying to make these revisions.

Ganyard: He's on the working group. Wants to respond to overlap and Brusich's comments. Agrees with Jolanda. Agrees that intent need to be clarified. Tries to separate the two categories, as others have done. In favor of keeping both.

Islam: Points out the overlap of the categories again....in favor.

Karau: Wants to call the question. Terry: OK

Sallak: Questions the authority to "call the question"....Draney states he thinks it's the speaker's prerogative, and Terry nonetheless goes back and asks for NEW comments....

Berns-Herrboldt asks if categories could be word-smithed...Terry says we need to vote on this motion first.

Brusich notes that the 30 credits could still stand if Senate wants....

**VOTE** to combine these categories into one with 3 credits: 9/27/1 Motion FAILS.

Sallak moves to amend the proposal: Creative and Artistic Outcome 1:

"necessary to create and execute a work of art." changed to "necessary to create, execute, or interpret works of art." Sallak/Brusich

Discussion:

Sallak...the roles of creator vs interpreter is sometimes discrete, sometimes not....it varies. Wants to keep all the traditions on the table.

Ganyard: We actually already approved it...Bree disagrees....Clif is in favor. Brusich is in favor. More inclusive. Murrenus Pilmaier is also in favor.

VOTE to change the objective as above: 36 yes/2 no/0 abstain Motion Passes.

Sallak requests to amend the proposal: Courses in the domain of creative and artistic inquiry must fulfill 2 of 3 of the requirements, not all three. Sallak/Cherry

Discussion:

Sallak: Comes with full support of Music unit...specific to performing arts. Few courses satisfy all three outcomes, but many meet two.

McQuaid-Dewhirst: Skills-based pedagogy versus history/context of arts....very different things, and a tall order for performing arts.

Sallak: There is a breadth versus depth aspect here. Two categories allows for much more depth.

Berns-Herrboldt: So you are OK with students only getting 2 of 3? Sallak: Yes, Music is.

VOTE on the amendment: 26 yes/4 No/5 abstain Motion passes.

Brusich wants to propose an amendment: Amend the requirements to include that students must take one course from each of the Colleges. Brusich/Gear

Discussion: Vandenhouten: where in the proposal will the criterion be added?

Also, CHESW is fairly distinct, and probably wouldn't be able to support on gen. ed. from each College.

Hillhouse: This might create a bottleneck; this is taking too much time, we need to move on.

Sallak: Does one course = 1 cr. or 3 cr.?

Sallmann: Reiterate: CHESW can't do this.

Terry asked for additional.....calls question:

Vote on 4 college amendment: 1 yes/32 no/3 abstain Motion Fails.

Move to close debate (Dirienzo/Atwood) no discussion allowed: (34 yes/3 no/0 abstain) Motion Passes.

VOTE to accept new core curricular proposal as amended: (32 yes/4 no/3 abstain): MOTION PASSES

#### 5. NEW BUSINESS

#### a. Suspension of Economics Program (Matt Dornbush)—First Reading

Dornbush: These discussions are very personal. The discussions on economics aren't a referendum on faculty and students. They are not responsible for changes like this. The Higher Ed environment is changing nationwide. We're had two faculty in economics for a while. We used to have 34 classes....these faculty have the highest number of unique preps. Hard to hire a professor into that environment. We now offer ~15 courses. Four courses are 92% of all student credit hours. The rest are very small classes. There are 36 majors total. Its become unsustainable, which the advisory board confirmed. 1) things have changed 2) the economics major is less important than economics curriculum

in the business school. That's where the emphasis needs to be. The major is getting in the way of how the economists can contribute to the university.

#### [move to extend meeting 5 minutes....by consensus]

Dornbush: We're going to focus on spreading economics around the campus. We do have five years, but if we brought Economics back, we'd want it to be special.

No time for questions. First reading.

Subject: Software processing mistake in CourseLeaf

#### Dr. Lowery,

I am notifying you of a processing mistake I made while attempting to initiate workflow within CourseLeaf for the Suspension of the BS Economics program. Rather than hitting the Workflow button, I hit the Admin Save button, thinking I was saving my work. Upon hitting the button, it was clear that this initiated an actual action. As I did it for one of the two emphases, I repeated for the second emphasis for consistency, assuming it would route to the Registrar who could return to me or the appropriate next step in the process. I immediately messaged (12/8/2023 10:52 AM), then spoke with (12/8/2023 10:54 AM) on Teams, Assistant Registrar Hrivnak to correct the routing, and was quite surprised to learn that they are unable to reverse this process, thus requiring this memo. I apologize for this rather embarrassing misstep on my part. The Assistant Registrar messaged me on Teams (12/8/2023 11:18 AM), "the good news is that your name is on the proposal activity, and you did include the detailed support rationale (you can see it if you click on the History for Dec 8, 2023)" suggesting the AAC will be able to view the electronic record. It appears that my mistake will require a more traditional "paper" processing to document the correct workflow.

For your convenience, the justification I provided was:

Per the Department of Accounting & Finance vote on 11/29/2023 (7 in favor, 0 opposed, 0 abstentions) the BS Economics will be Suspended and no longer listed as a major option at UWGB after the current 2023-2024 AY catalog. Per UW Policy 3.4: Policy on University of Wisconsin System Array Management: Program Planning, Delivery, Review, and Reporting, "suspending admissions allows a university to temporarily remove a program from the statewide academic degree program array and, if appropriate, within five years of the program's suspension, reinstate the program when demand and resources justify the continued operation of the program without Board of Regents (BOR) approval. When in suspension, the program in question is not included in the systemwide array or listed in electronic publications." Emphasis will now be placed on expanding the impact of the economics discipline, first within existing CSB majors (by far the current largest ECON student credit hour consumer) and through an improved and refocused minor, and second through expansion of opportunities with disciplines outside of the CSB. Additional documentation including a detailed discussion of the process leading to this decision and meeting minutes from 11/29/2023 have been shared with the Associate Provost.

#### **University Committee Meeting Minutes**

#### January 10, 2024

#### **Minutes Approval**

December 13, 2023 and January 3, 2023 minutes—approved by consensus.

#### Suspension of Economics Program (Matt Dornbush)

Programs have had some challenges for some time. Matt explained the rationale for the proposed suspension of the program. Current enrollment at about 36; the school looks to move from an emphasis to a major with over 100 students. Advisory wanted graduates to have strong economics understanding but integrated within one of the other business majors—maximize the impact of the discipline. Unanimous faculty vote to suspend the economics program. Have strengthened the minor. Should the major be brought back, needs to have some differentiated offering. A vote was taken per the University Committee curricular policy, Bill made the motion, seconded by Patricia to move the matter forward to Senate. Motion carried unanimously.

## Provost – Program Array Discussion (Kate Burns & Courtney Sherman)

Updates: (1) University received the Carnegie classification for community engagement. (2) St. Norbert's has approached for 2 +2 or 3 +2 (graduate) options. Are willing to honor our tuition rate (for students who would start here and continue on to St. Norbert's). (3) Theater and Dance discussions still ongoing. (4) Academic Affairs has shared budget proposals with Business and Finance—focus on ongoing (instead of one-time) with limit on personnel impact. (a) Reduce S & E. (b) ad hoc instruction offsets, use 189 [Collaborative revenue] ongoing (c) reassignments (d) overloads/reassignments. Will get into as can over the next month.

Questions from the UC: (1) SOFAS position—still under discussion of what needs are to determine how best to cover. CATL assist is planned; still need to determine shared governance. Kim did work on prework of the spring semester responsibilities prior to transitioning to other positions. The SOFAS support position is on the position savings in the budget proposal (funding is retained but position not). (2) Marinette-still looking to announce status for fall semester courses by end of the month. Library for both Marinette and Manitowoc being finalized. Reacting to news media who was contacted re: books being thrown away. Dumpster drawing attention. (3) Tuition—those admitted for fall as the Marinette campus will retain the current tuition structure. The goal will be to maintain this rate until the student graduates. Beginning fall of 2024, no longer count Marinette as a campus for system enrollment. After the 2024-2025 AY, will be unable to declare Marinette as a home campus. We are in year 1 of the tuition equalization plan.

#### **CWC Update (Jena Richter Landers)**

Committee recommitted to working toward the existing charge. Will send questionnaire to faculty and staff non-salary "pain points" with potential solutions; fits with Item 3 (a) of the charge. Suggested idea

of sitting with Chairs over chairs reimbursement. Focus on small but meaningful efforts. Climate Survey might also be a source of information. Report will be added to the Senate agenda for Jena to present.

#### **Additional Issues**

Fee structure for those who do not utilize the campus resources (e.g., online students).

Reimbursement for summer instruction adjustments.

Follow-Up: Assistant Teaching Professors and faculty status—Melissa Nash sent some information to Laura. Clif will send on to the committee.

#### **University Vision/Values - Next Steps**

Manitowoc/Sheboygan vision—Discussion of coordinating course scheduling. Differing needs of high school age versus returning adults. Planning monthly discussions at the campuses. Sense of community on these campuses (over transactional) was discussed.

Next steps: How to go about defining the vision? Grass roots approach to visioning? Will work expended be reinforced by administration? College visions—perhaps start with review and then could feed into a larger university vision. Role for the non-academic units? Idea of "lunch with the UC".

#### **Next week**

Melissa Nash will attend the meeting. Will review administrator evaluations in closed session at the start of the meeting.
